

Simplification of the import and export process

In this area, your company will enjoy special tax and exchange treatment and will be able to process raw materials and export completely tax free. From the point of view of development strategy, the fundamental role of ZPE Suape in Brazil is to provide highly competitive international conditions for Brazilian and international companies through tax-free exports of your products. Therefore, your products will become as competitive as those produced in areas with international incentives.



Main benefits for your company

Complete tax exemption - your company will have every guarantee of an excellent performance and high competitiveness in international markets

- Suspension of import tax, IPI, AFRMM, PIS/Cofins, PIS/Cofins Importation (including machines and equipment used)
- ICMS exemption (Confaz agreement 99/1998)
- Exemption of licenses from federal organs
- Exchange freedom (100% of revenue from exports can be kept abroad)
- Conditions ensured for 20 years, renewable for another 20 years
- Legal security and stable "rules of the trade"
- Sell 20% of production internally (in this case, paying all taxes).
- Sell 80% of production externally (tax-free).
- Reduction of 75% for IR on all profits for 10 years (Sudene)

As well as the benefits of paying the lowest possible amount of taxes, there are other benefits associated with the excellent location of ZPE/Suape which reduces logistical expenses and facilitates exportation via Suape Port. Improvements in the current law are being discussed in the National Congress based on proposals by the Brazilian Association of ZPEs. The most significant points involve increasing the percentage of production for internal sales to 40% and permission to provide services within the customs area.



Area with incentives. integrated with the first steelworks plant for flat steel in the Northeast

The Steel Processing Zone (ZPA) is an area that provides incentives for companies that use steel as a raw material. In this area, your company will enjoy complete integration with the Suape Steel Company (CSS), the first steelworks plant for flat steel in the Northeast. The ZPA will provide semi-finished materials for use as raw materials in construction projects and electronic equipment factories, among others. The production will attend to the growing demand in the area for civil construction companies, white line products — ovens, refrigerators, machines, equipment — as well as the naval and automobile industries.



Main benefits for your company

- Reduction of costs related to shipping on purchase of inputs, since the Laminadora plant that provides the raw material is beside the ZPA
- Unique logistical condition to attend to the market: strategic location ensuring proximity to the consumer market (faster and cheaper delivery).
- A model that is completely integrated to the other enterprises and services offered by Cone Suape (Multimodal, Multicenter, Cone Concierge), as well as the other structural projects of the Port
- State fiscal incentives, with deemed credit of up to 95% of the payment due to the ICMS
- Flexibility in the approval of Prodepe projects through Cone Concierge
- Companies established in the ZPA can enjoy fiscal benefits even before the initial operations of the Indústria Laminadora da CSS (importation of inputs and national purchases)





CONEAGREGADOS

Different areas of activity integrated together

Cone's newest business unit is Cone Agregados. Along with the other five existing units - ZPA, ZPE, Multicenter, Multimodal and Plug & Play – it is an important developer in the Complex.

Located in the expansion area, above the ZPE, with a total area of 22 ha (22,000 m2), Cone Agregados has arrived to offer three areas of activity that are independent, but interconnected. It is a veritable cluster, with companies united to produce material that is absorbed from within, generating aggregate value for the final customer. This is one of the greatest attractions for companies who wish to set up in this area.



Quarry, pre-mould and concrete works

Cone Agregados operates through the three following areas:

- Quarry Cone Natural Resources: area of 6 ha and a final product of gravel, which will be sold to different companies in the civil construction area. Cone will have an area of immense stones at its disposal, which are natural resources and the basis of any quarry. In addition, a leasing service of machines that transform stone into gravel will be offered through a partnership with one of the world's largest companies in this area: Lafarge. The operation is carried out through a system in which the supplier of the machine will be rewarded by the volume of production, all under the control of Cone.
- Pre-mould area of close to 15 ha, half of which will be used by Cone
 and half of which will be leased to companies in the region. This segment
 offers several advantages such as high productivity, faster operations and
 lower costs.
- Concrete works area of 1 ha, leased to Lafarge, another of Cone's clients.
